- Community Benefit Fund A total of \$229,091 awarded across the electorate including kitchen facility upgrades at Cooran State School; Weightlifting equipment and a defibrillator for Noosa Barbell Club; food trailer for the Lions Club of Noosa Heads: Rescue Boats for Wildlife Noosa and Sunshine Beach Surf Life Saving Club; equipment for Pomona and District Community House; plus many more!

This year has had its challenges, not only for those affected by the housing crisis, border closures, separation from families, or various mandates and their impacts; but also those whose incomes have been devastated. Our businesses and workers have faced enormous hardships, increasingly unable to afford rents whilst managing COVID requirements. Government staff and services have been overwhelmed with traumatic cries for assistance in multiple realms. Our frontline workers - many diverted to roles never predicted due to this 'bug' - working triple shifts as well as bearing the brunt of anger from frustrated Queenslanders. We have all learned much through these times, and will continue to from future challenges, with our own brand of resilience and care for all.

Amongst our COVID dominated world, the usual role of MPs and governments did not pause. There have been some historical determinations including those with terminal illnesses having their voice heard in Parliament, with the passing of the Voluntary Assisted Dying Bill. In addition, instrumental turning points in our society through acknowledgment that change is urgently needed, whether in relation to our youth offenders, behaviours on social media or how our parole systems work.

As a member of Parliament's Legal & Safety Affairs Committee, we held public hearings into some of Queensland's greatest concerns including serious vilification and hate crimes which social media has amplified. Freedom of speech comes with the responsibility not to humiliate or persecute others, and we cannot rest until respectful debate and discourse is restored. WHAT DOES STATE **GOVERNMENT DO?**

There is often confusion surrounding the three levels of Government, their representatives, and what they do!

State and Territory governments administer laws and provide services not covered by the Federal Government such as hospitals, schools, police and housing. The Federal Government has broad national powers and administers laws in relation to defence, immigration, foreign affairs, trade and taxation. The powers of Local Councils include responsibility for building regulations, rubbish collection, local roads and pest control. The representatives of these three levels of government work independently of each other, although there are times when collaboration is welcomed and necessary, in order to get resolution.

The role of a State Member of Parliament (MP) is a multifunctional one, having responsibility to our constituents, as well to broader Queensland. We provide assistance and advice to those in difficulty, act as a champion for local interest groups and issues and negotiate outcomes for our electorate.

As an Independent, researching Bills and consulting with stakeholders and community are vital parts of the decision making process. Meeting with constituents and attending the hundreds of events, seminars and functions both at home and in Brisbane, is both educational and inspiring!

My Electorate Office staff assist by accessing information and advice, and making representations to the relevant Minister's office. As with every process there are rules to follow. The role of an MP does not allow intervention in a judicial process or civil matters, and rightly so. Should the process or system fail, then an MP's role is to advocate for a review of these, and the underpinning legislation.
