### Hot Issues

**Noosa River Management Plan** - The final stage as of 1 January introduced a 28-day anchoring limit across the entire river system. These changes as reported many times are the culmination of community advocacy dating back to 2015 (though some say beyond that!) including a Community Jury, recommendations from the Noosa River Stakeholder Advisory Committee (NRSAC), and consultation by Maritime Safety Queensland (MSQ). Even though they were not legislatively required to, as existing regulations could have been changed under their current powers, opportunities for feedback were provided throughout the development of the plan, and criticism has overlooked key facts. These include that liveaboard regulations have not changed, only to anchoring regulations affecting all vessels over five metres in length. There has always been a requirement for anyone living aboard a vessel to hold a permit and comply with anchoring and pollution controls, and those on a mooring, jetty or marina and who hold a valid liveaboard permit are not affected by these amendments. As of last week, there were approximately 120 non-compliant vessels, of which 20 are permanent liveaboards with 20% of these having contacted MSQ demonstrating hardship. We continue to investigate any claims brought to our office, requested a 'Statement of Reasons' and review of the implementation of the regulations, a holding/laydown area for vessels whose owners are currently unable to comply, and prioritisation for residents on the mooring waitlist. Since the plan's release in 2023, I have been clear that no resident was to become homeless from any changes and will fight to ensure MSQ honours their commitment to this. In addition, not tolerate further vitriol from those who have never shown any interest in protecting these residents. **Former TAFE site** – The reassessment of the buildings has been completed by the owners, the NRA Collaborative, with the original proposal to reinvigorate as a school of design no longer viable due to deterioration. The alternate proposal they have put forward is for independent seniors living, one of the few allowable uses under the site’s zoning, with assurances given by the owners that no clearing or impact to biodiversity overlays and koala habitat will occur. While the proposed development addresses an identified housing need, we continue to advocate that affordable worker accommodation, as our most pressing need, be prioritised. As well reiterated the importance of Noosa Council being fully involved in the assessment and consultation process, to ensure that the views of the Noosa community and the intent of the local planning scheme are properly considered. Understandably, as a community we remain angry over the sequence of events since 2014 that led to this, however it is time to move forward and work to ensure this type of waste by governments never occurs again. **Operation Sandstorm** - QPS conducted further enforcement operations across Noosa North Shore, Teewah and the Cooloola Recreation Area over the Christmas period, with more than 230 Traffic Infringement Notices issued, including over 90 for speeding, with the highest recorded speed of 83 km/h occurring in the 40 km/h Teewah zone. More than 500 Random Breath Tests and 60 Random Drug Tests resulted in charges against three drink drivers and eight drug drivers. Even though these efforts are appreciated, we continue to raise with the relevant ministers the need for stronger measures to address unacceptable and dangerous behaviours whether on our roads and paths, or national parks. The Cooloola Recreation Area Management Plan is expected to be released soon, and we will update once it is available.

**Turtle Nesting Season** - Volunteers have been hard at work since the beginning of the nesting season to locate nests on Teewah Beach, with them reporting 21 nests at the time of writing, and a number disturbed by vehicle traffic resulting in damaged and destroyed eggs. Hundreds of viable eggs have been moved to safer positions so that these loggerhead and green turtles hatch in the coming weeks so please, can everyone assist by slowing down, not driving during dusk/ night/high tide and staying well off the dunes when walking or driving. These dudes head towards moon/starlight in their journey to the ocean, and our headlights and torches create confusion!

## From the Chamber

**Electoral Reform** – In the final sitting of Queensland Parliament for 2025, amid urgency motions and cognate bills, the Government tabled legislation framed as “electoral reform” that would lift the ban on property developers donating to political parties and candidates. It would also change donation caps from a four-year parliamentary term to annual limits, potentially quadrupling donations over a single term. This runs counter to what Queenslanders have called for and to warnings from major inquiries including Fitzgerald, Operation Belcarra and Coaldrake. Real reform would ban all donations, as 78% of respondents to our Noosa MP Annual Survey supported, not expand them. Democracy should serve the public interest, not those with the biggest cheque books.

**Health, Environment & Innovation Committee** – While parliament has been on break over the Christmas holidays, our committee work has continued including on the inquiry into the Environmental Protection and Other Legislation Amendment (EPOLA) Bill. As I raised in my Statement of Reservation to the Committee report, there are concerns that these changes could have implications for Noosa, including a single access permit for activities across national parks, conservation areas and marine parks. The response from the department regarding control measures are not sufficient, as these have not been historically meeting community expectations. **SEQ Koala Conservation Strategy** – The Queensland Government is calling for community feedback to help shape a new South East Queensland Koala Conservation Strategy, aimed at reversing declining koala numbers and restoring critical habitat.
